## Examples of significant projects:

- Coordinated with various universities and library associations to address issues related to the
  settlement of the class-action litigation against Google for its book scanning project. Efforts
  include planning for drafting and filing an amicus brief with the federal court, and
  establishing an education and information program for university and library officials. The
  settlement was announced in November 2008 and rejected by the court in March 2011. It is
  currently in renegotiation.
